## **COURT FILINGS FOR BURLINGTON COUNTY**

Pleadings in Probate, Trust and Guardianship matters shall be filed as follows:

- All <u>initial pleadings</u>, (ie. Order to Show Cause & Verified Complaints, Motions, and Guardianship Complaint with Affidavits and proposed form of Order Fixing Date for Hearing and proposed form of Judgment) shall be sent in <u>paper form</u> with the appropriate filing fee to <u>Surrogate of Burlington</u> <u>County, 50 Rancocas Road, Mount Holly, NJ 08060 via regular mail, certified mail, Federal Express,</u> <u>UPS or hand delivery</u>, pursuant to NJ Rules of Court **AND** Simultaneously be sent by <u>email</u> to <u>tbathke@co.burlington.nj.us</u> for Guardianships and <u>tboyle@co.burlington.nj.us</u> for all other Court matters.
- 2. The proposed Order to Show Cause, proposed Order Fixing Date for Hearing, the proposed Judgment for Guardianship of Person and/or Property, and the proposed Order for Relief on Motion sent via email shall be sent as a <u>Word</u> document. All other pleadings should be in <u>PDF format</u>.
- 3. The Caption on the Pleadings shall include the Attorney's Name, New Jersey Identification Number, and <u>direct email address</u>.
- 4. Regarding "all responsive pleadings" (anything other than initial set of pleadings) in Order to Show Cause matters, as well as Motions, shall be sent as follows: A) "Original" responses and replies are to be sent in <u>paper form</u>, with the appropriate filing fee, to <u>Surrogate of Burlington County, 50 Rancocas Road, Mount Holly, NJ 08060</u>; B) **AND** <u>Email</u> copy to <u>tbathke@co.burlington.nj.us</u> for Guardianships and <u>tboyle@co.burlington.nj.us</u> for all other court matters; C) <u>AND</u> "Courtesy copy" <u>via email</u> to the Superior Court, Chancery Division, Probate Part at <u>Charles.Doebley@njcourts.gov</u>.
